NOTICE OF SUPPLEMENTAL AUTHORITY

In further support of its petition, the Consumer Financial Protection Bureau submits the attached Opinion and Order in *CFPB v. Harbour Portfolio Advisors*, No. 16 Civ. 14183 (E.D. Mich., Feb. 16, 2017) (dkt. no. 19) (*Harbour*).

In *Harbour*, the court granted the Bureau's petition to enforce several civil investigative demands (CIDs), rejecting the argument that the Bureau lacked authority to issue the CIDs because the respondents do not offer or provide any consumer financial product or service. The court held that this argument was "misplaced" because "Respondents are raising a premature defense to an enforcement action, rather than a challenge to the Bureau's investigative authority. Whether the Respondents' transactions *actually* involve 'credit' is not at issue, and it would be premature for the Court to decide that question at this stage." *Harbour* at 6.

J.G. Wentworth, LLC's (JGW) argument in this case is similarly premature. It, like the *Harbour* respondents, argues that the Bureau lacks authority to issue the challenged CID because JGW does not offer or provide any consumer financial product or service. *See* CFPB

Resp. to JGW Opp. to Pet. at 2-3. The *Harbour* court rejected this argument, and this Court should, too, for the same reason.
