1. Any amicus briefs in support of Plaintiffs' Motion will be due 14 days after the Court enters an order adopting this Stipulated Briefing Schedule.
2. Defendant's Response to Plaintiffs' Motion will be due 28 days after the Court enters an order adopting this Stipulated Briefing Schedule.
3. Any amicus briefs in opposition to Plaintiffs' Motion will be due 42 days after the Court enters an order adopting this Stipulated Briefing Schedule.
4. Plaintiffs' Reply in Support of Plaintiffs' Motion will be due 56 days after the Court enters an order adopting this Stipulated Briefing Schedule.

The parties' stipulation to the above briefing schedule does not constitute advance consent by any party to the filing of any amicus brief.
